





MORRINSVILLE COLLEGE (126) Enrolment Scheme

Effective from 1 January 2024

The development and operation of enrolment schemes is undertaken under authority granted under Schedule 20 of the Education and Training Act 2020, which describes the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below shall be eligible to enrol at the school.

The zone begins at 624 Top Road (addresses below 624 are not in-zone) and extends east to cross State Highway 27 at 2041 SH27 (addresses below 2041 are not in-zone). From this point it extends east (including Maukoro Landing Road) to the Piako River, following the river south to the Waitoa River.

The boundary follows the Waitoa River to include North Road, and from the eastern end of North Road crosses Paeroa-Tahuna Road at 289 Paeroa-Tahuna Road (addresses above 289 are not in-zone).

From 289 Paeroa-Tahuna Road the boundary extends south and west, crossing State Highway 27, to the Whakahoro Road – No 8 Road intersection. Whakahoro Road is not in-zone. No 8 Road addresses north of the No 8 Road - Whakahoro Road intersection (numbers 230 and below) are in-zone.

From the No 8 Road - Whakahoro Road intersection the boundary travels west to the Piako River, and then follows the Piako River south to the point it is crossed by Haumia Road (Manhire Road is not in-zone).

The zone includes only Horrell Road addresses south of Haumia Road (Haumia Road is in zone).

From the point the Piako River is crossed by Haumia Road the zone extends north-west to include State Highway 27 addresses south of No 4 Road (to 5632 State Highway 27), but not No 4 Road or Horrell Road between State Highway 27 and Haumia Road.

From the State Highway 27 - No 4 Road intersection the boundary extends east to cross No 7 Road at 455 No 7 Road (No 7 Road addresses above 455 are not in-zone) and then to the No 1 Road and No 2 Road intersection (only No 1 Road addresses between State Highway 26 and No 2 Road; and No 2 Road addresses between No 1 Road and State Highway 27 are in-zone).

The zone extends from the No 1 Road and No 2 Road intersection to the Seddon Road and State Highway 26 intersection (Seddon Road and Thomas Road are not in-zone).

From the Seddon Road and State Highway 26 intersection the zone extends to the Chudleigh Road and Waikehau Road intersection, to include all of Ngarua Road, but not Chudleigh Road. Only Waikehau Road addresses to Chudleigh Road intersection are in-zone.

From the Chudleigh Road and Waikehau Road intersection to the Parker Road, Diagonal Road, and Piraunui Road intersection. Parker Road and Piraunui Road are not in zone, Diagonal Road is in zone.

From the Parker Road, Diagonal Road, and Piraunui Road intersection the boundary extends south including Given Road, to cross State Highway 27 at 6049 State Highway 27.

From 6049 State Highway 27 the zone extends west to 137 and 134 Campbell Road (Campbell Road addresses below 134 are not included). From there it continues west to 249 Hutchinson Road (Hutchinson Road addresses above number 249 are in-zone). The zone includes Pakarau and Cuff Roads. Harper Road is not included.

From 249 Hutchinson Road the boundary extends to the Paratu Road and Morrinsville-Walton Road intersection. Morrinsville-Walton Road addresses 1735 and below are in-zone, Paratu Road is in-zone.

From the Paratu Road and Piakonui Road intersection (Piakonui Road is not in-zone) the boundary extends south and then west to the to include Waterworks Loop Road (Te Miro Road is not in-zone) and from the Waterworks Loop Road and Te Miro Road intersection, extends north and then west to cross Scotsman Valley Road at 613 Scotsman Valley Road (only addresses 613 Scotsman Valley Road and above are included inzone).

From 613 Scotsman Valley Road the boundary extends north to cross Tahuroa Road at 306 Tahuroa Road (only addresses 306 Tahuroa Road and above are included in-zone).

West of 306 Tahuroa Road the boundary crosses Tauwhare Road at and crosses Tauwhare Road at 1408 Tauwhare Road (only addresses 1408 Tauwhare Road and above are included in-zone), then Hunter Road at 71 Hunter Road (only addresses 71 Hunter Road and below are included in-zone), and State Highway 26 at 1397 State Highway 26 (only addresses 1397 State Highway 26 to the State Highway 26-Seddon Road intersection are in-zone).

From 1397 State Highway 26 the zone extends north, including Friedlander and Schollum Roads, to Piako Road, but not including Holland Road, Seddon Road, or Waverley Road.

The zone continues west to include Piako Road addresses to 520 Piako Road (Piako Road addresses below 520 are not in-zone), and includes Shewan Road up to 284 Shewan Road (addresses above 284 Shewan Road are not included).

From 520 Piako Road the boundary extends north, including all Middle Road, to cross Woodlands Road at 652 Woodlands Road (Woodlands Road addresses below 652 are not in-zone).

From 652 Woodlands Road the boundary travels east, including Law Road, to cross Whitikahu Road at 728 Whitikahu Road (Whitikahu Road addresses below 728 are not in-zone)

From 728 Whitikahu Road the zone extends to include Orini Road addresses (Lucien Place is in-zone) to the intersection of Orini and Woodward Roads (Woodward Road is not in-zone).







From the intersection of Orini and Woodward Roads the zone extends west and then north to include Tauhei Road, Tainui Road and Kiwi Road, and crosses Tahuna Road at 2213 Tahuna Road (Tahuna Road addresses below 2213 are not included in the zone). Mohring Road and Hapuakohe Road are in-zone.

From 2213 Tahuna Road the zone extends north and then west to include all of Mangawara Road, and from the northern end of Mangawara Road extends east, to include Waiti Road, Old Hill Road and Pouruiri Road, to 624 Top Road, where the zone began.

Note: Both sides of all streets and roads included in the above description are included unless otherwise stated.

Proof of residence within the home zone will be required.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date which will be published in a daily or community newspaper circulating in the area served by the school. This will enable the board to assess the number of places which can be made available to students who live outside the home zone.

Out of Zone Enrolments

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority:

- **First Priority** this priority is not applicable at this school because the school does not run a special programme approved by the Secretary for Education.
- Second Priority will be given to applicants who are siblings of current students.
- **<u>Third Priority</u>** will be given to applicants who are siblings of former students.







- <u>Fourth Priority</u> will be given to any applicant who is a child of a former student of the school.
- **<u>Fifth Priority</u>** will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.

Sixth Priority will be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, Selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary, under Schedule 20, Clause 3 (1) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
